TOWN OF GREAT BARRINGTON REGULATIONS FOR AN ANNUAL VENDORS LICENSE

The purpose of this legislation is to provide for a legal mechanism by which downtown merchants will be able to safely vend merchandise outside of their stores.

- 1. In accordance with **521 CMR 22.2 of the Architectural Access Board.** Width of *walkways* shall be not less than 48 inches (48"=1219mm), excluding curb stones. An unobstructed path of travel shall be provided which is at least 36 inches (36"=914mm) *clear*, excluding curb stones.
- 2. "Transient vendor", any person, either principal or agent, who engages in a temporary or transient business in the Commonwealth selling goods, wares or merchandise, either in one locality or in traveling from place to place.
- 3. "Temporary or transient business", any exhibition and sale of goods, wares or merchandise which is carried on in any tent, booth, building or other structure, unless such place is open for business during usual business hours for a period of at least twelve consecutive months.
- 4. The sale by hawkers and peddlers of jewelry, furs, wines, or spirituous liquors, small artificial flowers or miniature flags is prohibited.
- 5. Any person licensed under this regulation shall keep said license in his/her possession which shall be readily available for display. The license shall indicate the license number, and shall include the licensee's signature and shall indicate the expiration date. The licensee shall display such license when requested to do so by any officer of the Police Department or the Health Agent.
- 6. No person licensed under this regulation shall conduct business in such a manner as would impede foot or vehicular traffic along or to a public way or public street or public sidewalk or access road or driveway.
- 7. All hawkers and peddlers shall have adequate trash control.
- 8. Vehicles utilized for the selling of frozen desserts or confections must have installed on said vehicle an amber flashing light visible from the front and rear of vehicle and such light must be flashing when the vehicle is stopped for the purpose of transacting business.
- 9. People doing business as transient vendors may conduct their trade only on property that is business zoned. Prior to commencing business, the transient vendors may conduct their trade only on property that is business zoned. Prior

to commencing business, the transient vendor shall submit to the licensing authority a signed and notarized statement from the property owner granting permission to vend or to so use the property.

10. Failure to comply with this regulation may result in suspension or revocation of the license granted hereunder. In addition, a penalty of twenty dollars for each offense may be assessed.

Further regulations:

- 1. This vending license is valid in the downtown business district only.
- 2. The building owner shall have the right of first refusal each year to apply for the license. This license is valid for the area directly in front of said building. The merchants who occupy said building shall have the right of second refusal. Said license shall only be available to the general public should the building owner and merchant choose not to purchase the license. The license shall not be resold for any money or barter or trade of any kind.
- 3. The Town of Great Barrington shall be named as "additional insured" on the Certificate of Liability Insurance that is provided by the applicant.
- 4. The Town may discontinue issuance of said license at any time.
- 5. The Town may revoke any building owner, merchant, or third party's temporary vending license at any time.
- 6. Town Manager may change the terms of this license and the regulations governing this license at any time.
- 7. Town Manager may void any or all requirements of this license for non-profit or community oriented temporary vending.
- 8. This license should not be considered to have any bearing on signage regulation i.e. sandwich boards, or outdoor dining.
