- 6. Chairman Flach took over the meeting at this point and Mr. Pruhenski remained present to take notes and answer questions.
- 7. A general discussion on the direction of the Commission took place and it was decided that Mr. Flach invite a State COD representative to attend the next meeting (Jeff Duggan). It was also decided that members would reach out to neighboring COD's to find out how they operate and learn more about the roles and responsibilities of being a COD member.
