Call to Order: The Chair will conduct a roll call to identify attendees. All votes taken during the meeting will be roll call votes. All participants please identify themselves before speaking.

1. Notice of Intent (DEP File # 167-0436) from Foresight Land Services on behalf of Leonard Felson & Julia Rosenblum. The property is at 56 River Street, Map 14 Lot 258. The proposed work consists of stabilizing a section of Housatonic Riverbank and related site work including construction of a planted structural bank stabilization system to mitigate against future erosion during storm events. This public hearing is being conducted in accordance with the Massachusetts Wetlands Protection Act and the Great Barrington Wetlands Protection Bylaw and is **continued from December 9, 2020**.

2. Request for Determination of Applicability from ACCORD Engineering & Surveying, LLC on behalf of William F. Nolan. The property is a 1.39 Acre parcel fronting on the north side of Blue Hill Road., Map 36 Lot 35E. The proposed work includes clearing, thinning and clean-up throughout the outer 50 feet of Buffer Zone adjacent to an Intermittent Stream and a Bordering Vegetated Wetland. This public meeting is being conducted in accordance with the Massachusetts Wetlands Protection Act and the Great Barrington Wetlands Protection Bylaw and is **continued from February 24, 2021 pending a site visit**.
