- **1. Notice of Intent (DEP File # 167-0440)** from S-K Design Group on behalf of Allegrone Construction Co. property is at 78 Christian Hill Road, Map 32 Lot 57E. The proposed work consists of construction of a single family house with garage, driveway and associated sitework within the 100 ft. buffer zone of a Bordering Vegetated Wetland.
- **2. Request for Determination of Applicability** from Mass DOT Highway Division, property is within the existing layout of Route 23, State Road. The proposed work consists of constructing a new sidewalk from Giddings Street eastward to about 700 ft. east of Laurel Street.
- **3. Request for Determination of Applicability** from Okerstrom Lang Ltd. on behalf of Kristen & Thomas Knox, property at 317 Long Pond Road, Map 34 Lot 11A. The proposed work consists of constructing a new bluestone terrace and pruning a view window through the existing tree branches below the canopy looking westward across Round Pond.
- **4. Notice of Intent (DEP File # 167-0436)** from Foresight Land Services on behalf of Leonard Felson & Julia Rosenblum. The property is at 56 River Street, Map 14 Lot 258. The proposed work consists of stabilizing a section of Housatonic Riverbank and related site work including construction of a planted structural bank stabilization system to mitigate against future erosion during storm events. **Continued from December 9, 2020.**

- **5. Notice of Intent (DEP File # 167-0437)** from Berkshire Engineering on behalf of Steven Bankert, property is at 49 Pearl Street, Map 11 Lot 47. The proposed work consists of constructing a 10 foot by 15 foot addition along the western face of the existing house and converting an existing patio into a 10 foot by 20 foot sunroom along the southern face of the same house. **Continued from April 28, 2021.**
