1. CALL TO ORDER

Discussion of an Enforcement Letter sent to James Larkin on January22, 2018 pertaining to his filing an NOI to restore/compensate for alterations to resource areas at the confluence of the Green and Housatonic Rivers (Map 38 Lot 44). **Continued from December 20, 2017.**

David Shanahan said that the oxbow had not been previously delineated as Bordering Vegetative Wetlands. Mr. Shanahan said this new addition is extremely unfair to the Larkin's and the Conservation Commission really dropped the ball to accommodate them. Andrew Mankin said the Commission was waiting for the complete delineation from Foresight Engineering and DEP. Mr. Shanahan said a letter should have been sent to the Larkin's sooner than it was.

David Shanahan left the meeting.

Discussion of an Enforcement Order issued to Debra Storey and Kenneth C. Storey on October 18, 2013 and the related Forest Restoration Plan prepared and submitted by Forester James W. Kelly and approved by the Commission on February 26, 2014. <u>+</u>29 Acres off West Sheffield Rd., Map 30 Lot 112.3.

Forester, Jim Kelly said he is still trying to get in touch with the property owner, Debra Storey. Mr. Kelly said he has found a new address and is going to send her a letter. The Commission agreed that they would like the Conservation Commission Agent to work with Mr. Kelly to set up another site visit prior to the February meeting.

Distribution of MACC Membership Cards and notice of Annual Environmental Conference.

Citizen speak time:

Christopher Wiltshire introduced himself as the candidate for the Conservation Commission Minute Scribe position.

- Gaetan LaChance announced that the application for CPA funds was submitted. If awarded the funding should be available July, 2018. Mr. LaChance explained that the funds will be directed towards projects at the McAllister Wildlife Preserve. The projects will include Jess Truro's work on habitat restoration as well as the maintenance work done by Will Conklin and the Greenagers.
- The Commission discussed inviting a pesticide use professional, possibly from UMass Amherst to present to the Commission as well as other Local Conservation Commissions. Lisa Bozzuto said that she welcomes any presentation but she does not think there is enough information to support that any usage of pesticides is safe for the environment. Andrew Mankin is in agreement with Ms. Bozzuto.
