# MEETING MINUTES November 30, 2022

**TREASURER'S REPORT:** Treasurer Avery reports a balance of \$39,283.53.

### **DIRECTOR'S REPORT:**

Updates:

#### Generator

- Paid for by a grant of \$15,000 through the Great Barrington Police Department
- Has the capacity to keep the senior center fully operational as usual
- The senior center closed November 21 for installation

## **GB COA transportation**

- Polly proposes an increased pay for drivers of GB COA Transportation.
- All drivers work a flexible, part-time schedule
- We welcome a new driver, Michael Harrigan, to round-out our workforce
- Transportation now has five drivers and three trained staff members who can drive and fill-in when necessary
- Micro-transit pilot program "nothing new to report"

#### Kitchen upgrades

- DPW superintendent, Joe Aberdale, met with Polly to go over some of the upgrades and will look into grants that tie into emergency shelter programs.
- Expansion of the kitchen area is also under consideration
- B & G Restaurant Supply agent met with Polly to explore the prospects of what appliances would be most suitable for our needs.

Commercial kitchen warranted

• On average, 18 meals prepared by Elder Services are served on-site every weekday.

• In-house prepared meals typically attract a larger crowd. Usually about 30 to 40 seniors

will attend.

• In the event that the Senior Center is used as a shelter, a commercial kitchen will be

optimal.

**BOARD SPEAKS:** 

Member Doug Wilber shares his knowledge pertaining to kitchen upgrades and generators and

offers suggestions directed towards what may be feasible.

Polly briefs the board on the Town Managers' explication of **The First Amendment Auditors** 

rights under the first amendment and what the citizens' response should be when confronted by

this such and such a group.

Chair Rutstein discusses Open Meeting Laws and gives an example of a conflict of interest.

Member Bailey asks Polly what other upgrades she would like to have for the senior center.

Essentially, Polly would like to have an awning/canopy or some building structure for protection

from inclemate weather at the entrance to the senior center.
