Applicant Donna Norman was present with Travis Derr to discuss a wall mounted sign on the back of 307 Main Street. The sign will face the Tom's Toys parking lot.

Mr. Hankin asked about the window.

Mr. Derr said the sign is just below the window.

Mr. Derr said he had no knowledge of the sandwich board sign.

Mr. May said sandwich board signs do not go through the Committee because they are temporary and can be moved.
