Call to Order:

Request for Determination of Applicability from Asher Israelow and/or Heather Fisch of Housatonic MUSE (Multi-Use Studio Experiment), property at 430 Park Street in Housatonic, Map 2 Lot 50. The proposed work includes construction of a handicap access ramp on an historic mill building within the 200 foot Riverfront Resource Area of the Housatonic River. **Continued from January 29, 2020.**

Request for Determination of Applicability from Randy Mills, on behalf of Townsquare Media Berkshires, property at 425 Stockbridge Road, Map 29 Lot 29-5. The proposed work consists of excavating a 5' x 5' x 5' hole in the asphalt paved parking lot in front of an existing cell tower adjacent to the WSBS building where the applicant proposes to pour concrete ballast to support a 5 ½ " OD pipe upon which to mount a communications satellite dish. The proposed excavation is within the Buffer Zone of a Bordering Vegetated Wetland.

Notice of Intent (DEP File # 167-xxxx), from Foresight Land Services on behalf of the Town of Great Barrington. The subject property is the former roadbed located at Old Route 7/ Rt.7, Stockbridge Road, Map 36 Lots 25, 25A, 27, 27A, 30.1 and 30C. The proposed work consists of construction of a new ± 1,964 foot long multi-use path along an existing sewer and abandoned State Highway Right of Way between the parking lots of Barrington Brewery to the south and Community Health Plan (CHP) to the north. Related work includes the construction of a retaining wall, installation of signage, painting of the proposed pavement and site grading to insure handicapped accessibility.
