Health Agent, Rebecca Jurczyk reviewed the changes added into the proposed regulations. The title of the regulations was changed to *Manicuring, Manicurist, and Nail Salon Regulations* to encompass the entirety of what the new regulations are intended to cover. The definition of Nail Salon was edited to include any business providing nail enhancement services. The Board agreed to give salons three full years from the promulgation of the regulations to achieve full compliance with proper ventilation requirements. Ms. Jurczyk separated the section formerly labeled as Appendix A from the Regulations and created a supplemental document titled "*Manicuring, Manicurist, and Nail Salon Guidelines*." The section outlining injury reports was amended to require more patron information and for salon operators to keep injury reports on file unless otherwise specified by the Board of Health.
