B. <u>APPROVAL OF MEETING MINUTES:</u>

C. <u>HEALTH DEPARTMENT UPDATES</u>:

Health Agent Rebecca Jurczyk discussed late fees assessed in surrounding Berkshire County Towns. December 17th is the deadline for renewing permits for 2022 in Great Barrington. 2021 Permits expire December 31st, 2021.

Chair Michael Lanoue requested we add this as an agenda item in January.

D. Great Barrington Housing Authority Extension Requests:

Health Agent Rebecca Jurczyk reviewed outstanding Correction Orders for Units 12 and 27. The Correction order for Unit 12 Bernard Gibbons Drive was issued on September 3rd, 2021. They have fully corrected all violations except one; the chronic moisture issue which does take time to eradicate.

The Correction Order for Unit 27 was issued on November 8th, 2021. The main complaint from resident was mold. At this point progress has not been made on this correction order. An email was received requesting a two week extension.

Chair Michael Lanoue suggested we grant an extension on these two Correction Orders, but would like to see communication from the Housing Authority. A formal letter or written request should be received within one week in order to issue a 30 day extension. Request from the Board to hear any public comment. No comments were made.

Chair Michael Lanoue recommended a re-inspection since the entire Correction Order is being contested.

Health Agent Rebecca Jurczyk reviewed the timeline of events starting with the initial complaint, and findings listed on the Correction Orders. One of the two units (Unit 1) has since been vacated so that

deadline can be on hold until that unit is re-occupied, if it is.

Cynthia McCallister, 52 River Street, Great Barrington: Reviewed the process she went through with purchasing the house, and notifications given to the Tenants. Cynthia discussed her disagreement with the Correction Order and what steps she took to address the findings on the Correction Order.

Chair Michael Lanoue suggested we re-inspect both units. Health Agent Rebecca Jurczyk mentioned there is no deadline now on the unoccupied unit. Cynthia is now occupying the vacant unit and agreed to allow a re-inspection in the vacated unit.

Chair Michael Lanoue requested we move to public comment.

Nan Wiles: Was present at the residence as a friend showing neighborly kindness. In no way was she officially representing the tenant.

Health Agent Rebecca Jurczyk requested to the Board that a hold be put on the Unit 1 Correction Order until the Unit is re-occupied by anyone other than the owner.

Agreed with Miss McCallister to re-inspect on December 21st, 2021 unless an earlier date can be established.

Health Agent Rebecca Jurczyk reviewed the moratorium language and intent draft with the Board and made edits.

Public Comments: Tom Zetterstrom, Commented on the application form. Suggested looking at State and surrounding town's guidelines and regulations. Give some of the people who employ herbicide applications to define what makes logical sense for Great Barrington.

Nan Wiles: Two suggestions: 1. The Board of Health should do outreach to abutters. 2. Businesses submitting the applications would like a courteous response from the Board of Health.

Andrea Panaritis, 30 Seekonk Road: Commends the Board for moving in this direction. Also a Bee Keeper. Discussed flowering periods of plants, limiting applications to times when pollinators are not so active, and inform Beekeepers of when applications are taking place as bees tend to travel beyond property abutters.

Vivian Orlofsky: Discussed how pollinators are effected by glyphosate. We need to provide recent information, like how the bee's internal systems react to glyphosate.

Tom Zetterstrom, prior comments he made were about previous meetings. The question is will the town be responsible for invasive plants? Environmental management is complex but the benefits outweigh the costs.

Board members Peter and Ruby would like to know which species are being sprayed. Board Chair Michael Lanoue would like this question added to the application form for educational purposes. Tom Zetterstrom: Outreach and education of management of invasive plants is what he does. He will drop off brochures to the Board of Health.
