B. HEALTH DEPARTMENT UPDATES:

111 active cases this week. The Southern Berkshire Public Health Collaborative has been organizing pop up clinics. The dates are listed on the Town Website and Facebook page. Dr. Ruby Chang discussed the different types of testing and instructions on how to correctly obtain a sample.

C. BHRSD LETTER TO THE BOARD OF HEALTH:

Requesting a decision from the Local Board of Health on implementing a policy on the COVID-19 Vaccination for School aged children. Continued from January 6th meeting.

Health Agent Rebecca Jurczyk presented the Board with a draft letter response to the Berkshire Hills Regional School District (BHRSD).

The Board discussed in detail their thoughts on editing and additions to the above mentioned draft.
