#### **REGULAR MEETING**

<u>Winged Liberty Lighting-</u> Vice-Chair Mercer noted that Lenox is proposing exterior lighting for their monument on the island in the town center. He suggests that new exterior lighting would enhance the Winged Liberty statue. Chair Howe noted that the HDC should have an update from the Town on the status of proposed site improvements including the proposed separate restroom building.
