A. Memorial Field Update – Michael Powell from Powerhouse Square was present to update the commissioners on the project. He advised that Phase I is completing and the parking lot will be finished in the next month or two. Phase II will be built only if financials work out. The commissioners noted that they thought the new dugout and new back stop and seating would be completed by now. The commissioners stated that they are willing to do the project at Memorial Field as a capital project this fiscal year at a cost of approximately \$60,000. It was explained that no access road to Phase II would be allowed if the town completes the Memorial Field project. The parks commissioners stated that the field needs to get up and running. It was further explained that the Town needs a date, time and completion certain and it needs to be known within the next month about the plans. The capital requests are due by 2/20/19. It was also noted that the backstop is in the wrong place and it doesn't have sides on it to prevent cars from being hit by balls.
