- Update from Ruby Aver regarding Tai Chi at the Housatonic Community Center Ruby noted that there has been up to 8 people at one time. People are distanced at 20' apart and masked. The committee will discuss creating a use plan for the Community Center in February or March.
- Railroad Street Youth Project to flood the skate bowl to use as an ice skating rink. (Discussion/Vote) There was a lengthy discussion with Railroad Street Youth Project about creating a skating rink at the skate park. Many members of RYSP were present to explain their ideas. Nadia Makuc and Laurel Ralph are two youth coalition co-chairs who are part of the project idea. Sam Riva is Railroad Street mentoring and skate park coordinator. Eric Bruun, Regina and Gertrude and Bob Redpath were also present. The plan is to flood the skate rink and to have programming around that. The water department will assist as needed. The size of the rink is 146 x70. The tarp would be at least 150 x 80. The weight of the tarp would be 640 lbs. The hose will be stored in the shed. There will be 3 staff people. 1 person to count attendance. Karen explained the maintenance of the ice through her experience. - Chris Rembold donation of equipment at Lake Mansfield Chris Rembold gave a presentation of the 3 pieces of equipment that the Judd and Susan Shoval Foundation would like to donate to the Lake Mansfield beach area. The donation consists of a swing, a tunnel and a climber. The donation amount is approximately \$40,000 which includes instillation. Karen said that one of the strap swings could be replaced with a handicapped swing. The plan includes wood chips. They are willing to consider a modest contribution towards maintenance. The equipment is for the age 5-12 age range. We need to get an egress that is wheel chair accessible to the playground equipment. (A copy of the schematics of the equipment is attached to these minutes). It was noted that the donors hired a surveyor at their own expense.
