Discussion: D. Bailly asked that the Police put up notices so that residents are aware of the change in parking. K. Burke has concern regarding Church Street parking, if both sides of this street are utilized for parking, it will become too narrow. This will be discussed in more detail.

6. OLD BUSINESS:

A. <u>Continuation</u> – SB to Approve Possible Regulations for Short Term Rentals to be put onto Town Meeting Warrant.

S. Bannon read the following statement prepared by E. Abrahams: I recommend that we not add additional items to the Town Meeting Warrant for several reasons.

- 1. The meeting is likely to be very long as it is. The zoning changes took 2.5 hours to explain and discuss at the Planning Board Meeting. While some of the changes have been withdrawn, it is still likely to be a long and controversial discussion. Add to that the water bottle ban, the renaming of the middle school, and hundred bridge TIFF, all controversial issues.
- 2. We have not had time to consider the Air BnB proposal and to look for unintended consequences, how much will an additional tax reduce the number of guests nights in town? What will the impact be on tourist dollars spent here? How many retired residents rely on this income to keep their homes? We should know the answers to these questions before we proceed. There has also been no time for public input. I am not saying we should not do this, I am saying we should take time to know the consequences before we recommend this. We do not have to wait a year, a special town meeting can deal with this and other items we are rushing to the ballot tonight.

Discussion:

K. Burke: This is a multi-tiered vote. The 6% local tax is already happening, as we tax hotels. We would be voting to first adopt a 3% Community Impact Fee for Professionally Managed Units which are units run by a professional, or ones that are owner-occupied in a 4-unit building. If this passes, it would change the 4-unit building designation into a 2 or 3 family home.

The goal is to get these short-term rentals to register with the town so that we have a better understanding of how many short-term rentals there actually are in the Town. A short term rental is defined as any rental of a property through a host site of 31 days or less, in a row. If they are rented for less than 14 days per year, taxes are not paid at all. The concern of allowing short-term rentals in residential neighborhoods is essentially allowing hotels in residential neighborhoods, which is non-conforming. This decision should not be made based on the financial impact the additional tax may have, it should be based on the appropriate use of Residential neighborhoods.

Citizen Speak:

Tracy Thornton - Great Barrington Resident, Operates Short-Term Rental

Feels creating a Registry is more work for the Homeowner as well as the Town, and is unnecessary, as the State does provide some information from their registrations that the Town could work with to see the number of short-term rentals.

K. Burke noted that the state registrants are not specific, address-wise. The Town is looking for more specific information as to how often the rental is taking place, if the home is owner-occupied, etc. It is a way to collect better information.

Claudia Lasley - Great Barrington Resident

Asked if there is a cost to register, and is there a list of what the registration would entail? Is the extra revenue going to be reviewed?

No, there would not be a cost, and the details will be available within a month. The revenue will be reviewed.

B. <u>Continuation</u> - Jennifer Clark - Update on the Purchase Installation, Models and Locations of the Water Stations. (Discussion/Vote)

The bylaw is in effect, and has been since January 1st. The enforcement of this law has been postponed to an unspecified date. Help educating the Citizens is being requested. Only about half of the businesses who sell water bottles are currently in compliance, and those who are not have said they have been given incorrect information by Town Hall employees. Ms. Clark provided a handout to be given to those with questions, and those responsible for answering these questions. Citizens can also go to www.gbontap.org for information. A number of businesses in town have agreed to fill water bottles for free upon request.

Funds have been privately raised for the first three water stations, to be installed at the Town Hall, the Mason Library, and at the Housatonic Community Center.

Seeking approval tonight for the models, locations, and installation of the water stations, as well as for the Town to agree to assume maintenance responsibilities after the first year.

MOTION: D. Bailly made a motion to approve the water station models, the three designated spots: Town Hall, the Mason Library, and at the Housatonic Community Center, and for them to be installed.

Wendy Kleinman - Great Barrington

Has been visiting merchants asking them to comply with the bottle ban. S. Bannon asserted that the ban went into effect on January 1, 2019, though enforcement is not yet in place. Letters to the Editors have been submitted, and we can again review. D. Bailly commented that the citizens approaching merchants are not Town representatives, and cannot take on the role of enforcing the ban.

C. Proposal to Change the Membership on the Strategic Sustainability and Livability Committee From 7 to 11 Members. (Discussion/Vote)

7. NEW BUSINESS:

A. SB - Proposal to Limit the Number of Marijuana Establishments. (Discussion/Vote)

S. Bannon read the following statement from Ed Abrahams:

Similar concerns to the Air BnB in respect to the length of the meeting, also there has been no study, public discussion, or public input. What is the impact on Commercial rents? How much money are retail marijuana customers spending on other establishments in town? How many is a right number? Are we limiting cultivation, manufacturing and transportation (we've had no applicants yet). What happens to the current license if a license holder wants to sell? What is the process and criteria for giving our scarce licenses? Will this freeze out micro-businesses who don't have the money to get to us first? There are two other marijuana related issues-both zoning- that need to come to Town Meeting. The Planning Board withdrew one due to time issues and two citizens proposed another to the Planning Board which have not yet been looked at. Again, this can be brought up at a special town meeting, allowing us to get public input and consider the best approach. Waiting for a Special Town Meeting will discussion at a meeting that hasn't already been going on for two hours. When the State opened the license proposal, we received 9 applications. We have received one since. We have time to do this right.

K. Burke: the concern is what will happen when marijuana becomes legal in NY/CT and nationally. There is nothing in the bylaws regarding a limit. K. Burke proposes a limit of four marijuana establishments be allowed, two of which be locally (Berkshire County resident of at least two years) or minority owned/economic empowerment business.

S. Bannon: We have approved 5, so they would be grandfathered in. Are Host agreements transferrable? K. Burke does not believe they are transferrable, and are on a 3-year renewal schedule.

MOTION: K. Burke made a motion to limit the number of retail marijuana establishments in Great Barrington to four. Two of those four must be locally owned, or a business of economic development.

SECOND: D. Bailly

Discussion:

D. Bailly: impromptu discussions have been had, especially as Host agreements have come up. Manufacturing is regulated through Special Permit anyway, so can be left off the books. He is hearing from citizens, that they are looking for some sort of limit. Town Meetings are usually long, and the Moderator can always continue the meeting to another night, in lieu of holding an additional meeting.

S. Bannon: Has reservations about this topic. Citizens have expressed concerns over number and locations of establishments.

B. SB - Amendments to the Sign Bylaw to Address Illuminated Signs. (Discussion/Vote)

Jonathan Hankin - Planning Board

The sign bylaw began in zoning, but was moved to the Town bylaws. This is seeking to allow Performance Venues to approach the Planning Board for a Special Permit to install a freestanding sign that has electronic messaging in place of a marquee. St. James Place is the specific venue in mind, as they currently cannot display their events.

- S. Bannon expressed concern over electronic signs on Main Street being out of place, and perhaps distasteful.
- K. Burke asked for confirmation that this would go through Design Advisory. Jonathan said he would encourage this, but they really have no "teeth".

Sally Harris - President, St. James Place

St. James Place has been open for two years, with 50+ organization performances, only two of which have not been Community based. St. James Place cannot afford to advertise in the way the Mahaiwe can. Banners are often made and hung on the Handicapped rail, but they cannot be read from the street, are not properly lit, etc. St. James' location is optimal, a sign would afford much more opportunity to share event happenings. The sign being sought is static, computer designed, and would not be "flashy".

Jenny Clark commented that specifications for these signs can be included in the bylaw, mas it is very general now.

MOTION: D. Bailly made a motion to send amendments to this bylaw to Town Meeting.

C. Rembold - Town Planner

Proposes to structure for Town Meeting:

Grouping of bylaw updates and clarifications (Downtown Business District, Design Advisory Committee, and others.)

Grouping of housing opportunities creation: changes to multi-family and two family development. Articles broken into separate items for clarification and ease of progression. B2 Zone Amendments/Stockbridge Road zoning map.

- 1. Community Preservation Fund Reserves/ Appropriations.

- 3. To Authorize the Selectboard to transfer property at 40 Grove Street to the GB Housing Trust Fund.
 - **J. Tabakin:** we own this property through Tax Title, in order for the GB Housing Trust fund to renovate or use for affordable housing, the property must be transferred, which requires Town Meeting approval. Legal proceedings on this are in motion.
- 4. To Approve Short Term Rentals Regulations "Community Impact Fee" per recent State Law.
- To Authorize the Selectboard to Enter into a Tax Agreement at 671 Stockbridge Road.
 J. Tabakin: This is parcel of land next to transfer station, at bottom of Monument Mountain. Current plans from owner are to put in solar panels. This does not approve

- the agreement, they will have to go through regulatory approval, but if it is approved, we would then enter into the Tax Agreement.
- 6. To Authorize the Selectboard to Enter into Tax Increment Financing Agreement and Tax Increment Financing Plan with Community Development Corporation of South Berkshires.
 - **J. Tabakin:** this agreement would support the development of the Assisted Living Facility on 100 Bridge St. that is in progress. The tax financing allows them to have enough capital to build the facility, and once the facility is running, it would proceed. This is seeking permission to discuss terms of this agreement over time. The agreement would come back to the Selectboard.
- 7. To Authorize Selectboard to Seek Approval to Purchase Street Lights owned by National Grid.
 - J. Tabakin: Seeking authorization from Town Meeting to begin discussions with National Grid. National Grid currently maintains the streetlights. If we own them, we would maintain them. It would be advantageous for the Town to own the lights on Main Street to be able to make adjustments to them: dim, use LED lights, etc. We would see if we can purchase just a section of lights, rather than all.
- 8. To Authorize Selectboard to Enter into a Ten (10) Year Contract for Recycling Processing Services.
 - **S. Van Deusen:** Presently, the recycling goes to the MURPH in Springfield, contracted privately through bulk purchase with Great Barrington and 72 other Towns. We receive a bulk discount and some revenue for this now, but it may begin to cost. J. Tabakin is not sure that signing a ten year agreement would be advantageous. Approving a 3-year contract is legal, but a 10-year contract would have to go before the Town for approval. **Citizen Question:** Jenny Clark, are we allowed to go over state lines? S. Van Deusen said yes, but the additional travel time would driver costs up.
- 9. ZONING: Amendments to Clarify and Update the Bylaw. 30 days is 30 calendar days.
- 10. ZONING: Amendments to Create Additional Housing Opportunities.
- 11. ZONING: Amendments to the B2 Zone and to the Zoning Map on Stockbridge Road.
- 12. To Amend Great Barrington Bylaw to change the Acceptance period for the Citizen Petitions from 30 days to 30 calendar days.
- 13. To Rename the Berkshire Hills Regional School District Middle School from Monument Valley Regional Middle School to the W.E.B. DuBois Regional Middle School. (by petition)
- 14. To Modify the Town Code Chapter 41, Article I subsection 41-7. (by petition)
- 15. To Modify the Town Code Chapter 135, Article II Subsections 135-6 through 135-9 called the water bottle ban. (by petition)

8. CITIZEN SPEAK TIME:

David Magadini - Great Barrington

The time period stated for the Citizen Petition was 29 days, not 30 as required in the bylaws. S. Bannon asserted that the Town Clerk did confirm it was a full 30 days, and met all requirements. Mr. Magadini commented that he wrote a letter to the Attorney General, and suggested the time period be reopened.
