5. PUBLIC HEARING:

A. National Grid and Verizon to replace existing pole 1 on Bridge Street to comply with safety construction standards required due to the Powerhouse Square Project. Pole to be installed will be of fiberglass type. Without the installation of fiberglass pole then National Grid requires structural support either across Bridge Street (impedes Powerhouse Square Project) or on same side of road (consuming parking spaces and impeding pedestrian traffic). Pole location begins at a point approximately 215 feet South-East of the centerline of the intersection of Main Street. Location shown on the plan attached. (Discussion/Vote).

- B. Explanation of the project:

Joanne DeRosa of National Grid explained that the pole that has been installed on Bridge Street is the best option for the location at this time. DeRosa explained to the Town Manager previously that a larger pole for Bridge Street was necessary due to the circumstance of the location. The pole is a stronger option since it is made of fiber glass. DeRosa explained that a fiber glass pole is the best and only option for that location. Board member Cooke asked why two poles attached together would not work and it was explained that two wooden poles, regardless of being attached together, would still not support the necessary weight. The fiber glass pole was the best option according to National Grid representative.

C. Speak in Favor/Opposition:

Michael Charles of Powerhouse Square spoke in strong favor of this pole due to its stability - otherwise a different pole with different wires and capabilities would interfere negatively with his initiatives at Powerhouse Square. Board member Abrahams asks National Grid to find a more aesthetically pleasing pole.
