1. CALL TO ORDER:

Chair, Sean Stanton called the meeting to order at 7:00PM

B. Review of Citizen Petition Process for Town Meeting Articles.

(Citizen Petition: Opens - January 22, 2018; Closes - January 31, 2018)

Petitions are now accepted in the Town Clerk's office Monday through Friday 8:30AM-4:00PM. All petitions must have at least ten signatures from registered voters in the Town of Great Barrington.

David Magadini, 334 Main Street. Mr. Magadini said the time frame in which to submit a citizen's petition is very short. Mr. Magadini proposed to extend the submission time to three weeks. Sean Stanton said that if someone intends to submit a petition for the Town Meeting warrant they do not need to begin the process on January 22, 2018 they can get the article drafted and signatures ahead of time.

4. TOWN MANAGER'S REPORT:

A. Department Updates.

- Ramsdell Library will close temporarily in order to repair the floors Monday, February 5th and will reopen on February 20th at 1:00PM.
- The Town Manager asked the Selectboard to sign the extension for the M.O.U with the Williamstown Health Agent, Jeffrey C. Kennedy.

Dan Bailly asked if the Town is continuing to look for a Health Agent to fill the position in the Health Department. The Town Manager said the Town is no longer seeking a Health Agent; Rebecca Jurczyk has been serving as an Agent as well as Locke Larkin who has extended his hours. Ms. Tabakin said that the Williamstown Health Agent is providing additional expertise and consulting to our current staff, who have been able to expand their knowledge. Ms. Tabakin said that this is working out well because we have been able to extend the capacity of our current staff.

- The Open Meeting Law complaint filed by Eileen Mooney on September 21, 2018 against the Selectboard was found by the Attorney General's office to not be a violation.

Bill Cooke asked if the Attorney has a cap on his expenses. Ms. Tabakin said that he has agreed to represent the town throughout the ZBA hearing process up to and not to exceed \$8,000.00.

Michael Andelman, Blue Hill Rd. Mr. Andelman asked whether or not it is an issue that the house on the property of 11 Roger Rd. is occupied. Mr. Andelman said that currently no one lives on the property. Mr. Andelman would like the Town Manager and Town Planner to look into whether a business can operate in a residential zone if the clause allowing the business to operate factored in that the business owner lived on premises. Mr. Andelman would like to know if the original ruling allows the business to continue without a residence.
