1. CALL SELECTBOARD MEETING TO ORDER-5:30 PM - OPEN MEETING

a. Board Members Present: Leigh Davis, Steve Bannon, Ed Abrahams, Bill Cooke, Kate Burke

b. DRAFT RESPONSE TO GB DECLARATION BY SELECTBOARD

- i. Leigh stated that after discussion with other Selectboard members, she has rewritten her proposed response to the "GB Declaration" (see meeting packet). She proceeded to read the letter. Ed noted that he greatly favored this version. Kate inquired as to why we were not requesting that the AIER not use our name (Great Barrington), to which Leigh responded that this is not within our control. Steve added that the letter was very good. Leigh motioned that the Selectboard accept the letter; Ed seconded. Roll call vote was taken. Motion passed unanimously. Leigh asked if the (separate) letter Mark had sent to the NY Times had been circulated. Mark responded that there had been no response as of yet, but the Town has circulated the letter nationally.
- ii. Leigh moved that the Selectboard authorize Mark distribute the letter which was just approved through Business Wire, and authorize the appropriate amount of funds for this. Kate seconded. A roll call vote was taken, with a 3-2 vote in favor. Steve, Kate and Leigh were in favor; Bill and Ed dissented.
- c. CITIZEN SPEAK TIME Citizen Speak Time is an opportunity for the Selectboard to listen to residents. Topics of particular concern or importance may be placed on a future agenda for discussion. This time is reserved for town residents only unless otherwise permitted by the chair, and speakers are limited to 3 minutes each.
