1. - a. Chief Walsh-Retirement
 - i. On behalf of the Selectboard, employees, and citizens of Great Barrington, S. Bannon congratulated Chief Walsh on his impending retirement. S. Bannon read statements from the Commonwealth of Massachusetts House of Representatives and Governor Charles Baker/Lieutenant Governor Karyn Polito.
 - ii. Chief William Walsh spoke to thank his family, the Town of Great Barrington, and his fellow officers.
- b. L. Davis asked if there was a way to put cones on Lake Mansfield when the ice is dangerous. S. Bannon thinks that caution signs should be put up.
- c. K. Burke thanked the Rotary, Town DPW, and the businesses for decorating the town this holiday season. K. Burke also thanked the town employees for the snow removal and salting.

5. TOWN MANAGER'S REPORT

- a. HWW Updates
 - i. HWW replied to the letter dated November 24th from the Department of Public Utilities. This response can be found on the Selectboard's page on the Town of GB's website.
- b. Police Chief Search updates and Transition Plans
 - i. The town is looking to fill the upcoming Chief of Police vacancy; seven-member committee has presented a list of finalists. M. Pruhenski is working to notify applicants and schedule interviews for January. Paul Storti will be interim chief, effective Thursday, December 24th.
- c. Community Impact Funding updates
 - i. Five-member committee has been reviewing applications, 5 awards totaling \$185,000 will be granted to local non-profit organizations.
 - 1. Berkshire Hills Regional School District \$80,000
 - 2. Railroad Street Youth project \$50,000
 - 3. Berkshire South \$25,000
 - 4. Volunteers in Medicine \$20,000
 - 5. Construct \$10,000
- d. Town-wide municipal phone system updates
 - i. This upgrade will enhance current municipal phone system that currently experiences many technical difficulties.

 - On December 15th, the Finance Committee reviewed the recommendation of discounting 14 categories of permits by 50%, or approximately \$21,000 in revenue. The Finance Committee unanimously supported this recommendation.
 - K. Burke feels that the board should consider discounting the licenses by 100% due to the pandemic. S. Bannon stated that that may a good idea, but that the citizens of GB may not be able to take on the addition tax burden. Anne O'Dwyer of the Finance Committee stated that the committee believed that a 50% discount was a reasonable compromise.
