# Selectboard Special Meeting via Zoom Tuesday, May 3, 2022

1. CALL TO ORDER SELECTBOARD SPECIAL MEETING BY ROLL CALL VOTE – Chairman Bannon opened the meeting at 6:00pm. Roll call: E. Abrahams, "aye," S.Bannon, "aye," L. Davis, "aye," E. Gabriel, "aye," Garfield Reed, "aye." All in attendance.

Additional attendees: Town Manager Mark Pruhenski, Assistant Town Manager Chris Rembold.

#### 2. SELECTBOARD'S ANNOUNCEMENTS/STATEMENTS

a. L. Davis stated Short-Term Rental should have been discussed at the meeting, but expressed her hope and determination for a vote at Town Meeting on the housing issue and encouraged citizens to move forward and weigh in.

### 3. TOWN MANAGER'S REPORT

- a. Housatonic Water Works (HWW)
- b. Date for next Housatonic Water Works Executive Session is May 18, 2022 at 6:00PM M. Pruhenski updated citizens stating an Executive Session was held last Wednesday to discuss strategy/approach for HWW and the discussion will continue in Executive Session on May 18.
- c. Draft letter to Housatonic Water Works regarding bottled water and home water filters M. Pruhenski asked for Selectboard input on the draft letter to HWW requesting relief for customers through bottled water, reimbursement, or a statement credit and for the provision of water filtration options to those significantly impacted or at risk.
  - i. L. Davis stated the letter should require a response. E. Abrahams noted the Selectboard does not have authority over HWW and suggested the letter be more of a request. The Selectboard discussed and agreed on wording "expect and appreciate a response."
- L. Davis made a motion to send the amended letter to Jim Mercer, Treasurer, HWW; E. Abrahams seconded. S. Bannon asked for any additional discussion there was none. Roll call vote: E. Abrahams, "aye," S. Bannon, "aye," L. Davis, "aye," E. Gabriel, "aye," G. Reed, "aye." All in favor, 5-0.
  - ii. M. Pruhenski stated the letter would be sent this week by certified mail.
