Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and Governor Healey's March 29, 2023 Revised Order extending remote participation by all members in any meeting of a public body, this meeting of the Community Preservation Committee will be conducted both in-person and via remote participation to the greatest extent possible. Specific information and the general guidelines for remote participation by members of the public and/or parties with a right and/or requirement to attend this meeting can be found on town's website, at www.townofgb.org. For this meeting, members of the public and committee members may attend the meeting in person, or, for those who wish to do so remotely may by following the instructions on this agenda. For those who are not in-person every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means.

- **3.** CPA Request from W.E.B. DuBois Center (f/k/a Clinton Church Restoration) for an extension of their grant from July 20, 2024 to December 31, 2024.
- **4.** Request from Berkshire Natural Resources Council to change the site of their FY21 grant for the Tom Ball trailhead/parking area from the north end of Long Pond Road, to a site on the south end on Alford Road, and to extend the grant by an additional year to June 30, 3025.
- **5.** Request from the Town that unspent portions of the historic preservation grant for the Trolley Shelter grant be used for handicapped accessibility upgrades at the Trolley Shelter.
- 6. Review budget status report of CPA projects funded to date
- 7. Town Meeting preparation discuss CPC report and CPA articles
- **8.** Reports from Committee Members: Committee members may give a brief report on any Community Preservation Act issues or projects from their board/commission
- **9.** Citizen Speak Time: This is an opportunity for residents to bring up topics of concern or importance which may be placed on a future agenda for discussion. This is reserved for residents only unless otherwise permitted by the chair, and speakers are limited to 3 minutes.

Pursuant to MGL Chapter 30A section 20 (f), after notifying the chair of the public body, any person may make a video or audio recording of an open session of a meeting of a public body, or may transmit the meeting through any medium. At the beginning of the meeting, the chair shall inform other attendees of any such recordings. Any member of the public wishing to speak at the meeting must receive permission of the chair. The listings of agenda items are those reasonably anticipated by the chair which may be discussed at the meeting. Not all items listed may in fact be discussed and other items not listed may also be brought up for discussion to the extent permitted by law.
