Call to Order: The Chair will conduct a roll call to identify attendees. All votes taken during the meeting will be roll call votes. All participants please identify themselves before speaking.

- 1. Notice of Intent (DEP File # 167-0440) from S-K Design Group on behalf of Allegrone Construction Co. property is at 78 Christian Hill Road, Map 32 Lot 57E. The proposed work consists of construction of a single family house with garage, driveway and associated site work within the 100 ft. buffer zone of a Bordering Vegetated Wetland. Continued from July 28, 2021.
- 2. Notice of Intent (DEP File # 167-0436) from Foresight Land Services on behalf of Leonard Felson & Julia Rosenblum. The property is at 56 River Street, Map 14 Lot 258. The proposed work consists of stabilizing a section of Housatonic Riverbank and related site work including planting native species. At the applicants request, continued from April 2021
- **3. Notice of Intent (DEP File # 167-0441)** from Tighe & Bond on behalf of the Town of Great Barrington, Department of Public Works. The property is within the Division Street Right of Way. The proposed work consists of replacing the superstructure of the Division Street Bridge over the Housatonic River with a prefabricated truss to be installed upon existing abutments.
- **4. Notice of Intent (DEP File # 167-0442)** from Foresight Land Services on behalf of the Town of Great Barrington Department of Public Works, property is on Christian Hill Road, Map 11 Lot 36. The work consists of stream crossing culvert replacement and related site work.
- **5.** Request for Determination of Applicability from Berkshire Gas Co. The property is within the Alford Road right-of-way. The proposed work consists of excavation and retirement of about 15 ft. of 2 inch steel gas main.

- **6.** Request for Determination of Applicability from Kelly, Granger, Parsons & Associates on behalf of John Paskus, property at 97 Brush Hill Road, Map 36 Lot 63.1. The proposed work consists of abandoning a failed system and installing a pre-treatment tank, a pump chamber and a drip irrigation septic field within the outer 50 foot buffer zone of an intermittent stream.
- 7. Request for Determination of Applicability from Berkshire Engineering on behalf of Wendy Pearson, property is at 269 Blue Hill Road, Map 41 Lot 9. The proposed work consists of demolition and removal of the existing residence and septic system and construction of a new residence, septic system, well and driveway within the previously developed area.
- **8.** Request for Determination of Applicability from Hill Engineers on behalf of Hazen Paper Co. The property is at 295 Park Street, Housatonic, Map 6, Lots 5-9 and the proposed work consists of demolishing and removing a portion of an existing building that is part of a historic mill complex.
