Call to Order: The Chair will conduct a roll call to identify attendees. All votes taken during the meeting will be roll call votes. All participants please identify themselves before speaking.

- 1. Notice of Intent (DEP File # 167-0436) from Foresight Land Services on behalf of Leonard Felson & Julia Rosenblum. The property is at 56 River Street, Map 14 Lot 258. The proposed work consists of stabilizing a section of Housatonic Riverbank and related site work including construction of a planted structural bank stabilization system to mitigate against future erosion during storm events. This public hearing is being conducted in accordance with the Massachusetts Wetlands Protection Act and the Great Barrington Wetlands Protection Bylaw and is **continued from December 9, 2020.**
- **2. Request for Determination of Applicability** from White Engineering on behalf of David & Judy Gilberg. The property, located at 316 Long Pond Road, Map 34 Lot 12F, consists of an existing contemporary style residence built in 2010/2011 with a free-standing garage. The proposed work includes construction of a second floor addition onto the garage, adding a pergola style flat roofed walkway connector between the house and the garage and converting the existing screened porch into an insulated glass enclosed seasonal living space. This public meeting is being conducted in accordance with the Great Barrington Regulations (Ch.217 Art.VII) under the Berkshire Scenic Mountains Act (Ch.131 Sec.39A).
- **3. Request for Determination of Applicability** from the Mass Department of Conservation and Recreation The property is a portion of Beartown State Forest, Map 40 Lot 1, including the woodland hiking loop trail around Benedict Pond in a mixed hardwood forest. The proposed work consists of up-grades and improvements at ten locations along the trail around the westerly end of Benedict Pond, crossing Buffer Zones, watercourses and Bordering Vegetated Wetlands. This public meeting is being conducted in accordance with the Massachusetts Wetlands Protection Act and the Great Barrington Wetlands Protection Bylaw.
- **4. Request for Determination of Applicability** from ACCORD Engineering & Surveying, LLC on behalf of William F. Nolan. The property is a 1.39 Acre parcel fronting on the north side of Blue Hill Road., Map 36 Lot 35E. The proposed work includes clearing, thinning and clean-up throughout the outer 50 feet of Buffer Zone adjacent to an Intermittent Stream and a Bordering Vegetated Wetland. This public meeting is being conducted in accordance with the Massachusetts Wetlands Protection Act and the Great Barrington Wetlands Protection Bylaw.
