- No more than two (2) driveways shall normally be allowed for any property, unless there is a C. clear necessity for more.
- D. Driveways shall not normally be approved at intersections, because of potential safety hazards.
- Culverts taking the place of roadside ditches shall have a diameter of not less than 15" (A culvert is not required at this location)
- Entrance elevation at the point of entry into the public right-of-way shall be no more than the elevation of the shoulder of the road.
- G. Driveways should be so constructed that water from the driveway shall not drain onto the crown of the road.
- H. In no instance shall the edge of the driveway entering onto the road conflict with the flow of surface
- Driveway width shall not more than 24-feet. Any curb at the entrance shall be rounded off with a radius of no more than 20 feet.
- Pitch of driveway shall be downward from the edge of the road to sideline of the town right-of-way J. or front property line.
- Driveways should be located to the best advantage with respect to the alignment with the way, profile and sight distance conditions. In no instance shall a driveway intersect the way at less than a sixty degree angle. Unless there is no alternative, a driveway should not be located within a required side yard.

- L. No permit shall be issued for any driveway to a structure or proposed structure on a grade in excess of ten percent (10%) above the road or street level until and unless the applicant submits plans to the Highway Superintendent showing that the driveway will be constructed in a such a way so as not to discharge water, stones or other materials onto any public street, road or highway. (A plan has been provided that shows a drainage system that water will not be discharged into the road)
- 2. Install a paved driveway apron in accordance with the following requirements:
- A. Apron dimensions: See attached Plans
- C. Place 3-inches of bituminous concrete on 12-inches of compacted gravel. Place asphalt tack coat along the edge of the road where the apron meets the edge of the existing pavement.


The applicant agrees to notify the Highway Superintendent (528-2500) at least 48 hours prior to the installation of the paved apron. (The driveway apron already exists)

- 3. Should there be, after completion of the driveway, discharges of water, stones, or silt onto the public way or onto property of any abutters or neighbors, the property owner shall take whatever steps are necessary to eliminate such discharges.
- 4. The applicant shall maintain the proposed access to conform to the following applicable condition listed under Section 153-17, Continuing responsibility of owners, of the Town of Great Barrington Code:

Abutting property owners shall be responsible for keeping culverts under their driveways cleared and for maintaining driveways in condition conforming to the requirements of the permit.



Draft Proposal to Great Barrington Select Board for Formation of the Strategic Sustainability and Livability Committee


To research, recommend, and support implementation of sustainability initiatives that have the maximum impact on reducing the town's greenhouse gas footprint, while improving resilience to the changing climate, and building community cohesion. Initiatives will be considered and selected not only for their impact on climate emissions but also for their impact on supporting affordability, accessibility, and cost savings for full-time residents.

Proposal:

Communities across the world are at a crossroads. We know that per the latest Intergovernmental Panel on Climate Change (IPCC) report, we have 12 years to act swiftly to mitigate the most devastating impacts of climate change. Of course, many communities in the United States and across the world are already experiencing these impacts. On a positive note, there are many workable, policy-centered steps a town like Great Barrington can take to address this grave issue on a local level.

Though on the surface it may seem unrelated, one of the many barriers to environmental action in our town is the crisis of affordability young families and working people are experiencing around housing and other services. This, while the town is developing rapidly with new commercial and residential properties, most of which are out of reach of the local working person. While Great Barrington made history by becoming the third community in the country to adopt a ban on single use plastic bottles and to directly address global pollution in this way, it also exposed a significant values fracture in the community, compromised community trust in the Town Meeting process, and drew time and money from town resources.

This committee would hope to broaden a traditional view of sustainability and environmentalism by considering a triple bottom line approach, which defines sustainability as including environmental, social, and environmental aspects (see below figure). Sustainability and environmental protection are core values in the Berkshires and Great Barrington. By advancing broad sustainability initiatives, the Town may be able to better retain and attract young residents to improve the vitality and economic sustainability of the Town.



This committee would seek to address issues of climate change -- including energy use, recycling, and other essential issues -- while being attendant to the multifaceted needs of the whole Great Barrington community. Having a strategic sustainability committee as a formalized part of Town Government will allow for a more holistic assessment of potential initiatives in the future, will bring a broader set of perspectives to the table, and will maximize the public benefit for future policy initiatives.

Additionally, the Town has been without a formal Green Committee for several years after receiving Green Community status. Another key focus of a subcommittee would be to support the Public Works Superintendent on identifying projects at municipal facilities that could utilize Green Communities funding and ensure that we are on track with reporting requirements to be eligible for future funding. These projects would support sustainability and energy goals while saving taxpayers money.

Potential activities:

- Researching efficiency and renewable energy initiatives to reduce Town Government's footprint while saving taxpayers money.
- Researching, proposing, and implementing community-wide policy initiatives.
- Engaging the community around sustainability, climate, and affordability issues.
- Advising town staff and the Select Board on sustainability work.
- Acting as an internal sustainability coordination body to ensure the Town's good work is promoted to the community and to break down any communication silos between town staff, elected officials, community members, and other committees.

Committee Member Selection:

We come to you as two Great Barrington residents who have been involved locally in climate and environmental activities, including as volunteer members of the Heat Smart Team over the last year. The primary goal for this proposal is to ensure the committee can be created. While we are very committed to seeing this committee through and getting it off the ground, we hope the Town will openly recruit diverse perspectives and expertises to come at this work from multiple angles, like contractors, architects, social justice, etc. The group should represent the diversity of our community, including age, race, income, employment types, and sectors of experience. We hope the committee can truly address sustainability from all angles and go beyond the choir of a typical environmental group to meet the growing needs of the town. We look forward to an active public recruitment process but would be honored to apply and be selected as well. More detailed information on who we are for reference can be found below.

Natalie Narotzky is a sustainability professional who has spent the last six years supporting local government sustainability officers at the Urban Sustainability Directors Network. She brings deep experience in local government sustainability and climate policy, which can inform potential initiatives to be considered. She is also involved locally as former coordinator of 350Mass Berkshires, member of the HeatSmart volunteer team, and the current organizer of Great Barrington's Green Drinks at the Prairie Whale.

Jovanina Pagano is a licensed social worker who has worked in the realm of adolescent development for many years, first in New York City and now in Great Barrington where she works as a clinician at the John Dewey Academy. In NYC, Jovanina directed programs providing educational support and advocacy for under-served youth and their families. Since moving to Great Barrington, Jovanina has expanded her focus from social justice to include environmental justice, joining the environmental group 350Mass and engaging with other local citizens to focus on environmental and climate change work at the local level. Jovanina was one of the HeatSmart volunteer team members, focusing on making the program accessible to lowand moderate-income citizens.

Each seminar also provides ample time for student interaction and testing for certification. Additionally, the three-year certification will satisfy the requirements of most local authorities and may save your store(s) a great deal of money on liability insurance.



MassPack offers "BAT" trainings throughout the state in both the spring and fall of each year. Dates and locations for the next series of BAT seminars and testing are now posted (see below).

ARTICLE 15:

To see if the Town will vote to transfer the care, custody, management and control of the approximately 8.34 acres of property on East Mountain, shown on Assessors' Map 37 as Parcel 53, to the Selectboard for the purpose of transfer or conveyance, and authorize the Selectboard to transfer or donate the property to the Commonwealth of Massachusetts, and to take all action and execute all documents necessary in connection therewith, or to take any other action relative thereto.

ARTICLE 16:

To see if the Town will vote to authorize the Selectboard to grant to the Great Barrington Land Conservancy certain perpetual land use rights, under a Natural Area and Trail Use Agreement with the Great Barrington Land Conservancy in connection with the construction, use and maintenance of a recreational trail, as shown on six pages of plans entitled "Easement Plan Prepared for the Great Barrington Land Conservancy Riverfront Trail," prepared by Foresight Land Services, Pittsfield, MA, which are on file with the Town Clerk, or to take any other action relative thereto.

ARTICLE 17:

To see if the Town will vote to discontinue as a public way the westerly portion of Manville Street, as shown on a Site Plan prepared by SK Design Group Inc. dated March 23, 2018, on file with the Town Clerk, and which portion is described as follows: Beginning at a point in the northerly line of Manville Street 568 feet westerly in said northerly line from the westerly line of Main Street; Running thence westerly in said northerly line a distance of 261 feet, more or less, to land now or formerly of the New York, New Haven & Hartford Railroad Company; Running thence southerly along land now or formerly of said Railroad Company a distance of 40 feet, more or less, to the southerly line of Manville Street; Running thence easterly in said southerly line a distance of 263 feet, more or less to a point; and Running thence northerly across Manville Street a distance of 40 feet, more or less, to the place of beginning, or to take any other action relative thereto.

ARTICLE 18: State Road Mixed Use (B2X)

To see if the Town will vote to amend the Zoning Bylaw by adding a new Section 9.14, State Road Mixed Use; amending Section 2.1.2, List of Business Districts; amending Section 3.1.4, Table of Use Regulations, amending Section 4.1.2, Schedule of Dimensional Requirements, as proposed below, and amending the Zoning Map as shown below, or to take any other action relative thereto.

Purpose of the Amendment: This amendment is proposed pursuant to the recommendations of the 2013 Master Plan to update the zoning in certain commercial areas within walking distance of a village center, to preserve and enhance the mix of residential and retail uses, and to reflect the context of the built fabric. This amendment would affect the area of State Road approximately between the Housatonic River and Belcher Square, as shown on the accompanying map, most of which is currently zoned B-2. Most of the B-2 parcels would be rezoned to B2X, while some would be rezoned to reflect their adjacent residential districts, e.g., R3 or R1B.

The existing B-2 designation allows for a wide variety of business and retail uses, but it is more restrictive

NATURAL AREA AND TRAIL USE AGREEMENT

This Natural Area and Trail Use Agreement ("Trail Agreement") is executed and effective on the last date written on the signature pages below and is by and between the TOWN OF GREAT BARRINGTON, a Massachusetts municipality, acting by and through its Selectboard pursuant to the vote under Article 16 of the warrant for the May 7, 2018 Annual Town Meeting, whose mailing address is 334 Main Street, Great Barrington, MA, 01230, its successors and assigns ("Licensor"), and the GREAT BARRINGTON LAND CONSERVANCY, INC., a non-profit corporation organized and existing under the laws of the Commonwealth of Massachusetts and having its mailing address as P.O. Box 987, Great Barrington, MA. 01230, its successors and assigns ("Licensee") (individually, a "Party" and together, the "Parties").

WHEREAS, the Town of Great Barrington is a municipality organized under the laws of the Commonwealth of Massachusetts and holds and maintains an easement in and through certain real properties for the use and maintenance of sewer lines and related appurtenances (the "Sewer Easement") as described in an instrument recorded in the Southern Berkshire Registry of Deeds at Book 384, Page 630 in locations shown on Plat File Map 61 of said Registry; and

WHEREAS, the Town of Great Barrington is also the owner of certain real estate pursuant to a deed recorded in the Southern Berkshire Registry of Deeds at Book 170, Page 485, (the "Olympian Meadows" ballfields), certain real estate pursuant to a deed recorded in the Southern Berkshire Registry of Deeds at Book 267, Page 289, (the "Soldiers and Sailors Memorial Field"), and certain other real estate pursuant to a deed recorded in the Southern Berkshire Registry of Deeds at Book 373, Page 564 (a 20-foot wide parcel) (collectively, "Licensor's Properties"); and

WHEREAS, the Great Barrington Land Conservancy, Inc. is a non-profit organization dedicated to the conservation and stewardship of natural resources and special places in the Town of Great Barrington for the benefit of the public; and

WHEREAS, the Parties are committed to the development and construction of a trail ("the Trail"), portions of which are to be located on the Licensor Properties and portions of which are to be located within the Sewer Easement area, as a scenic public walking trail, for passive recreation, and for the protection and preservation of wildlife and native plants; and

WHEREAS, the Licensor consents to the construction and maintenance of the Trail, as provided for herein, on the Licensor Properties and within the Sewer Easement area; and

WHEREAS, the Licensee has obtained easements for said Trail from the owners of the portions of the land in and through which the Licensor holds the Sewer Easement and upon which the Trail is to be developed and constructed; and

WHEREAS, the purpose of this Trail Agreement is to confirm the Licensor's grant of land use rights to Licensee to provide for public use of the Trail in perpetuity, and to clarify the obligations of the Parties concerning the construction, maintenance and use of the Trail;

NOW, THEREFORE, in consideration of, the mutual covenants, terms, conditions and restrictions herein contained the Licensor and the Licensee agree as follows, and the Licensor does hereby grant to the Licensee an easement in, over, and through the Licensor Properties and a license in, over and through the Sewer Easement area for the construction and maintenance of said Trail and, to the fullest extent possible, for public use thereof, upon the following covenants, terms, conditions and restrictions:

1) DESCRIPTION OF THE TRAIL LOCATION

The rights granted hereby are for said Trail, as described in the document entitled Trail Description and Site Plan, annexed hereto as "Exhibit A" and made a part of this Agreement.

2) USE OF THE TRAIL

The Trail may be used by the public and shall be used solely for passive recreational activities such as walking, hiking or snowshoeing. Bicycles and motorized vehicles shall be prohibited, except individuals with mobility impairments may use power-driven mobility devices appropriate for the trail, including motorized wheelchairs and scooters. The Trail will be open to the public, year-round, from dawn to dusk. However, the use limitations provided herein are not intended to limit the pre-existing rights of the Town of Great Barrington under its Sewer Easement or in the Licensor Properties, nor to limit the rights of the Licensor to use of the Licensor Properties in any manner not inconsistent with the rights granted herein to the Licensee, including access via emergency vehicles. The Licensee acknowledges the trail development and usage principles concerning sound ecological practices, safe access and public education in river stewardship outlined in the Master Plan of the Town of Great Barrington, as approved on October 10, 2013, and hereby agrees to comply with the same in the construction and maintenance of the Trail.

3) NATURE OF THE AGREEMENT

The license rights hereby granted by the Licensor to the Licensee, acting in the public interest, shall constitute a license for a term as long as is legally permissible and shall be binding upon the Licensor, and the Licensee shall acknowledge and incorporate the same by reference in any instrument granting rights in, on, or to, the Trail. This Agreement shall be effective on the last date that it is executed by the Parties.

4) RIGHTS OF THE LICENSEE

The Licensee, acting in the public interest, shall be responsible to perform the activities related to the construction, repair, and maintenance of the Trail, and may develop and provide educational programming associated with the Trail. The Trail will include, as determined by the Licensee, a treadway usable for passive recreation, and fencing, landscaping, signage, benches or other appurtenances. Licensor agrees to provide Licensee, its members, employees, agents and contractors, reasonable access over, upon and across the Trail in order for the Licensee to conduct these activities. The Licensee agrees to conduct all activities in a manner consistent with

the condition of the Trail, in compliance with all federal, state and local laws, and in a manner that does not unreasonably disturb the Licensor or its tenants. Licensee agrees to obtain all necessary permits and Licensor agrees to execute all necessary and reasonable forms and documents to assist Licensee in obtaining such permits. By way of illustration, the rights of the Licensee shall include, but not be limited to, the following:

- a) Clean-up and restoration activities such as the removal of garbage or debris, and vegetation management as well as invasive plant removal; however, the Licensee shall not use any herbicide without first obtaining prior written approval of the Licensor.
- b) Trail building and construction including grading and filling, but only as permitted under the Massachusetts Wetlands Protection Act; construction of drainage facilities; installation of signage, posts, benches and garden areas; placement of pathway surface materials; installation of erosion control and bank stabilization measures; installation of fencing, railings and lighting; provisions for safety and handicap access where appropriate; and provisions for vista outlooks.
- c) Maintenance and repair of the Trail and Trail structures;
- d) Scheduling and conducting of workshops and educational activities on the Trail;
- e) Use of power tools, generators and motor vehicles on the Trail and adjacent to the Trail but only in conjunction with activities described herein and only at reasonable times, which shall be determined at the discretion of the Licensor; f) Licensee will pay all costs related to design, development and construction of the Trail and has the right to choose all consultants, contractors and workpeople necessary for the construction and maintenance of the Trail, except as to any area where the Licensor voluntarily chooses to design, develop and construct a portion of the Trail.

Before commencing trail building, construction and other physical work activities, the Licensee shall provide the Licensor with ten (10) days' prior notice of the activities, including a written description thereof. The Parties acknowledge the Natural Habitat Areas existing in and around the Trail location and agree that all activities of the Licensee hereunder shall be in conformity with the requirements of the Massachusetts Department of Conservation and Recreation, Division of Fisheries and Wildlife, Department of Environmental Protection, and Natural Heritage and Endangered Species Program.

5) RIGHTS OF THE LICENSOR

The Licensor has the right to enter upon any portion of the Trail for any reason and to perform any construction, repair or maintenance to its sewer lines and equipment, drainage pipes, athletic facilities and other areas as it sees fit. The Licensor agrees to provide reasonable notice to the Licensee of such work and will return the Trail area, as nearly as practicable, to its condition prior to such performance. The Licensor may, at its option, choose to develop and construct a portion of the Trail on the Licensor Properties, but is not by such choice otherwise bound to any further maintenance of such portions.

6) LICENSOR'S REPRESENTATIONS

The Licensor represents that it has title to the Licensor Properties and has the right to enter into and execute this Trail Agreement.

7) RELEASE OF LIABILITY, REPAIR OF DAMAGE

Licensee hereby releases and agrees to hold the Licensor and its officers, employees, and agents harmless from and against any and all liability for bodily injuries, death, and property damage arising from activities performed and acts or omissions of Licensee or its agents, employees and contractors pursuant to or in connection with this Trail Agreement. Any damage to the Trail caused by either Party or its respective agents, employees or contractors shall be repaired by the damaging Party.

8) INSURANCE

Licensee hereby warrants that it has secured and will maintain for the duration of this Agreement a policy of comprehensive general liability insurance in the amount of One Million Dollars (\$1,000,000) per occurrence naming the Licensor, its successors and assigns, as additional insureds and will annually, on or before the anniversary date of this Trail Agreement, submit to the Licensor a certificate of such insurance. The Licensor shall have the right to require a higher coverage amount in the future so as to ensure that the amount of insurance coverage, consistent with accepted underwriting standards, remains comparable to coverage of \$1,000,000 as of the date of this Trail Agreement

9) NOTICE

All notices, reports or requests required to be given hereunder by either Party shall be sufficiently given if sent by certified mail to the Parties at their addresses listed in the first paragraph of this Trail Agreement, or such other replacement address as a Party gives notice of to the other Party in accordance herewith.

10) ASSIGNMENT

The Licensee shall not assign the rights granted by this Trail Agreement without the advance, written consent of the Licensor.

11) CHOICE OF LAWS

This Trail Agreement shall be governed in all aspects by the laws of the Commonwealth of Massachusetts.
