The Great Barrington Land Conservancy (GBLC) is in its 30th year as a land trust organization that supports land conservation, community trails, and farm preservation in Great Barrington. Our projects include the Housatonic River Walk, Riverfront Trail, Pfeiffer Arboretum, and Lake Mansfield Conservation Forest Trails.

Since 2011, GBLC has sponsored Run for the Hills 5K/10K, a 5 & 10 Kilometer Run & Walk event, as a way to strengthen GBLC, our town and local businesses. The event has proven to be successful and is an annual tradition.







EXECUTIVE SUMMARY

TITLE: Parking Ticket Processing

BACKGROUND: The police department is responsible for parking enforcement. Once a violation is issued, it's entered into the IMC software for tracking purposes. On a monthly basis, the police department generates a warrant listing all violations issued by our parking enforcement staff and sworn officers, and submits that report to the Treasurer/Collector's office. That office is responsible for the collection of fines. If a violation remains unpaid, they notify the Registry of Motor Vehicles (RMV) and request a renewal hold be placed on the owner's license and vehicle(s) registration. Managing the process of collecting fines, following up on unpaid violations, holding hearings to review appeals, and notifying the RMV, is time consuming and often falls to the low priority list.

To remedy this, I looked into a parking ticket processing service. The Plymouth County Treasurer's Office has a service that would help us streamline the whole process and it's utilized by a number of Massachusetts municipalities, including three (3) from Berkshire County.

FISCAL IMPACT: The cost of outsourcing the parking ticket process is at a minimum \$2.00 per violation issued. The maximum is \$3.10 per violation if it is not paid and a letter is mailed to the vehicle owner. These fees are deducted from the fees collected from Plymouth County, so we are not billed for the service. Each month we will receive a check for the parking fines collected, minus their administrative fee.

If we purchase a hand-held device for issuing violations electronically in the field, the cost would be a one-time expense for the equipment of \$1,152.00 and a reoccurring fee of \$22.00 a month for the data service. This cost can be also be deducted directly from the collection fees.

RECOMMENDATION: I recommend that we utilize this service and transition to using an electronic hand-held device for issuing violations in the field. The service complies with all the

statutory requirements for parking violations and the collection of the fines. Furthermore, I recommend that we consider reviewing our fine structure at a follow-up meeting. A slight increase in our fine schedule, which hasn't been increased in several years, would offset or cover entirely, any increased expense to the town as a result of this new program.

EXECUTIVE SUMMARY

<u>TITLE</u>: Assignment of Police Officers at Polling Locations

BACKGROUND: On June 22, 2022, the election reform law ("The VOTES Act") was signed into law by Governor Baker. The VOTES Act makes many of the changes from the pandemic permanent (i.e., Vote by Mail and Early In-Person Voting). Changes made to Section 72 of MGL 54 which now charges the Selectboard, rather than person in charge of the police force, with detailing a sufficient number of police officers or constables for each polling location.

FISCAL IMPACT: N/A

RECOMMENDATION: I recommend to the Selectboard, per the recently passed VOTES Act, Section 72, to assign a minimum of 1 police officer to the Great Barrington Fire Station (Precincts A, C & D) and a minimum of 1 police officer to the Housatonic Community Center (Precinct B) for all elections. Furthermore, I recommend the Selectboard designate the Police Chief or a police department designee the authority to assign specific police officers according to scheduling and availability.

SELECTBOARD VOTE

MOTION- Move to approve a sufficient number of police officers, but not less than 1, at the polling location at every election therein to preserve order and to protect the election officers and supervisors from any interference with their duties and to aid in enforcing the laws relating to elections, as required by Section 72 of MGL Chapter 54 which was changed in section 13 of Chapter 92 of the Acts of 2022. Further, move to designate the Police Chief or a police department designee the authority to assign specific police officers according to scheduling and availability. The Town Clerk will advise the Police Chief on the location and time the officers are needed for every election.

A Great Barrington Memorial to W.E.B. Du Bois

Several years ago, the Great Barrington Library Trustees approved the placement of a sculpture of W.E.B. Du Bois in front of the Mason Public Library. Sadly, Freke Vuijst, a local resident who initiated that project, died shortly after she received their approval.

A group of locals has taken up the cause and we hope you will join us. A sculpture of Du Bois will celebrate not only his achievements in the fight for racial equality, it will also acknowledge how Great Barrington—with its long abolitionist history and powerful commitment to public education—helped shaped the man Du Bois became.

W. E. B. Du Bois (1868–1963), was born and educated in Great Barrington, becoming the first African American to earn a Ph.D. from Harvard and to achieve world fame as a sociologist, historian, and founder of the NAACP. A born leader, Du Bois insisted on full civil rights for Blacks in an era of "gradualism" and backsliding. His collection of essays, *The Souls of Black Folk*, is a seminal work of African American literature. Controversial in his own time and even in our own, Du Bois is now recognized as a giant of the civil rights movement.

The Center of Our Community

The front of the Mason Library is already a popular gathering place on weekends, where visitors browse among books for sale. But the historic front steps are crumbling and, in repairing them, we see an opportunity to do more — to create a public space, a hub for play, socializing, and performance.

We propose a life-size bronze statue of DuBois, hand on a favorite book, gazing at the new plaza from a marble bench. The statue would be approachable, inviting us to join Du Bois—to sit, visit, read, and learn. Randy Weinstein, director of the Du Bois Center in Great Barrington, recently donated his Center's extensive collection to the Mason Library: how fitting that visitors will be welcomed to that collection by a statue of the man himself.

African American Heritage Trail

The African American Heritage Trail celebrates various communities in the Berkshires: Elizabeth Freeman is featured, as is the Du Bois homestead and family burial site. We believe the addition of a Du Bois monument on Great Barrington's main street will further promote the Berkshire's rich African American heritage. Restaurants, shops, and Inns will benefit, as will other cultural sites—including the new Du Bois Center for Freedom & Democracy (formerly known as Clinton Church Restoration)

Our Process

We will select a sculptor for the project through an open competition. Lauren Clark, a Library Trustee, who is also our board member and owner of the Lauren Clark Fine Arts Gallery, will lead our search committee. We are already reaching out to Black sculptors who are interested in the commission.

Our chosen sculptor will have the opportunity to work at Chesterwood, the Stockbridge museum/home of Daniel Chester French, who created the monumental "Seated Lincoln" on the Washington Mall. The work process will be open to the community.

A Community Project

We estimate that the commissioning and casting of the monument will cost \$200,000. Repair and redevelopment of the plaza will cost another \$125,000. The GB Select Board has agreed to accept the entire porject as a gift and maintain it once our work is complete.
