- In Section 7.18.4, item 3, change Planning Board to Selectboard.
- Delete items 4 and 5 and renumber item 6 to be number 4.
- Add a second row, "Marijuana Establishment, Cultivation," under the proposed C(13) in the table of uses so that Cultivation would not be allowed by right in any zone, allowed by Selectboard Special Permit in the I and I-2 zones, and in the R2 and R4 zones but only on parcels of 5 acres or more, not permitted in R2 and R4 on parcels of less than 5 acres, and not permitted in any other zone, as shown below.
- Add a third row, "Marijuana Establishment, Manufacturing," as shown below.
