**Call to Order:** The Chair will conduct a roll call to identify attendees. All votes taken during the meeting will be roll call votes. All participants please identify themselves before speaking.

- 1. Notice of Intent (DEP File # 167-0440) from S-K Design Group on behalf of Allegrone Construction Co. property is at 78 Christian Hill Road, Map 32 Lot 57E. The proposed work consists of construction of a single family house with garage, driveway and associated site work within the 100 ft. buffer zone of a Bordering Vegetated Wetland. At the applicant's request Continued to October 27, 2021.
- 2. Notice of Intent (DEP File # 167-0436) from Foresight Land Services on behalf of Leonard Felson & Julia Rosenblum. The property is at 56 River Street, Map 14 Lot 258. The proposed work consists of stabilizing a section of Housatonic Riverbank and related site work including planting native species. At the applicants request, continued to October 27, 2021.
- 3. Request for Determination of Applicability from Berkshire Engineering on behalf of Wendy Pearson, property is at 269 Blue Hill Road, Map 41 Lot 9. The proposed work consists of demolition and removal of the existing residence and septic system and construction of a new residence, septic system, well and driveway within the previously developed area. Continued from August 25, 2021.
- **4. Request for Determination of Applicability** from Foresight Land Services on behalf of Barbara Watkins, The property is at 38 Kalliste Hill, Map 32 Lot 13-59. The proposed work is the construction of a new single family home, garage, driveway and related site work.

- **5.** Request for Determination of Applicability from Mass DOT Highway Division. The property is the highway ROW at 420 Stockbridge Road. The proposed work consists of uncovering and cleaning out a drainage pipe under Stockbridge Road including uncovering and recreating the drainage swale at the inlet and outlet to allow the drain pipe to function as originally intended.
- **6.** Request for Certificate of Compliance (DEP File # 167-0395) from Hill Engineers on behalf of Egos South Realty, LLC, the owner of the Berkshire Eye Center at 409 Stockbridge Road, Map 8 Lot 1.A. The work that was completed in 2015 was the conversion of a drive through window area into enclosed office space.
- **7. Request for Certificate of Compliance (DEP File # 167-0355)** from Rob Akroyd of Greylock Design Associates on behalf of Daniel Jusidman property at 9 Buttondown Lane. The work completed was planting of numerous native trees within the riverfront of the Williams River in the spring of 2011. The property was inspected by the Conservation Agent and the owner's representative on 9-03-2021.
