Public Meeting: The Commission is holding this public meeting to consider a Request for Determination of Applicability from Conor Clark on behalf of Andrew and Margaret Morse, property located at 1 Butternut Lane, Map 42 Lot 38H. The proposed work includes regrading, spreading new top soil and planting new lawn within an existing fenced area.

Public Hearing: The Commission will hold a Public Hearing on a Notice of Intent DEP File # 167-0451 from Foresight Land Services on behalf of Berkshire Mountain Bakery. Property at 367 Park Street, Map 4 Lot 10. The proposed work consists of a 30' X 14' expansion of the existing outdoor walk-in freezer to be mounted on steel piers above ground.

Continuation of Public Hearing: The Commission will continue the Public Hearing on Notice of Intent DEP File # 167-0436 from Foresight Land Services on behalf of Leonard Felson & Julia Rosenblum, property located at 56 River Street, Map 14 Lot 258. The hearing was continued from 12/9/2020 to 2/23/2022 while details of property boundaries and bank stabilization techniques were finalized to the satisfaction of the DFW Natural Heritage Program.
