

## About Community Impact Funding

### ***What is it?***

Community Impact Funding (CIF) is money collected by the town from cannabis dispensaries and designated for things that are “reasonably related to the costs imposed upon the municipality” by the dispensary. The dispensaries in town agreed to pay 3% of total gross sales into Community Impact Funding for 5 years. The agreement runs from 2020-2025, making 2021 the second year in which funds will be collected.

### ***How are funds distributed?***

The CIF Committee advises the Town Manager on how best to allocate funds. The CIF Committee is committed to serving town residents across demographics (including income, ability, age, gender, and race). The Committee welcomes proposals from all entities—individuals, organizations, town committees, and town departments.

### ***How much money is available for funding?***

This year the Town has allocated \$350,000 to be distributed from this fund.

### ***What kinds of projects qualify for funding?***

According to the agreement between the town of Great Barrington and the dispensaries, “the Town shall use the above referenced payments in its sole discretion, but shall make a good faith effort to allocate said payments for road and other infrastructure systems, law enforcement, fire protection services, inspectional services, public health and addiction services and permitting and consulting services, as well as unforeseen impacts upon the Town.”

The CIF Committee has identified the following categories for funding:

- **Health and safety (particularly of our youth)**—Negative health impacts associated with cannabis use have been established, especially in adolescents whose brains have not fully developed. With dispensaries located in highly visible locations in town and the increased possibility that cannabis use is occurring in their homes, youth need reliable education regarding cannabis more than ever. For adults who struggle with substance use, the impact of readily available cannabis needs to be addressed.
- **Social engagement and community building**—Cannabis use is often associated with isolation, so there is now a greater need for promoting social engagement and community building.
- **Town reputation**—Being one of the first towns in Massachusetts with dispensaries has brought a lot of attention to Great Barrington. Some residents are concerned that the town is now strongly associated with its cannabis dispensaries.
- **Infrastructure/parking**—Dispensaries have increased traffic (both pedestrian and vehicular), as well as the demand for parking and public amenities in town.
- **Criminal justice**—People of color continue to be disproportionately impacted by convictions related to past cannabis laws.

### ***What are the criteria for consideration?***

Projects must address one or more of the above categories. Priority will be given to:

- Organizations based in Great Barrington
- Programs that benefit a large number of people, especially Great Barrington residents
